Sailing Instructions (SIs)

1. RULES

1.1. The event is governed by the rules as defined in *The Racing Rules of Sailing*.

1.2. If there is a conflict between languages the English version takes precedence.

2. CODE OF CONDUCT

2.1. [DP] Competitors and support persons shall comply with reasonable requests from race officials.

3. SIGNALS MADE ASHORE

3.1. Signals made ashore will be displayed at the host club flag pole.

4. CLASS FLAGS

4.1. The class flag is a white flag.

5. COURSES

5.1. Courses are described in Appendix A.

5.2. The race committee will display a flag indicating which course will be sailed.

6. MARKS

6.1. The marks that will be used are SLVYRA buoys.

7. THE START

7.1. The starting line will be between a staff displaying an orange flag on the signal vessel at the starboard end and the course side of the port-end starting mark (mark 32).

7.2. Boats must start according to their time indicated on the Start Time List.

7.3. Any boat starting before her assigned starting time will be recalled by the race committee on VHF Channel 77. The boat must go around the ends of the starting line and restart at or after her assigned start time.

7.4. A boat that does not start within five minutes after the last scheduled boat will be scored Did Not Start. This changes RRS A5.1 and A5.2.

8. THE FINISH

8.1. The finishing line will be between a staff displaying a blue flag on the finishing mark at the port end and the course side of the starboard end finishing mark (mark 32).

9. TIME LIMIT

9.1. The Finishing Window is the time limit for a boat to finish after the first boat starts, sails the course and finishes. The Finishing Window for this race will be 45 minutes.



9.2. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized or given redress, will be scored Did Not Finish without a hearing. This changes RRS 35, A5.1 and A5.2.

- 9.3. A boat scored Did Not Finish will be attributed a score of zero. This changes RRS A5.2.
- 9.4. Failure to finish within the Finishing Window will not be grounds for redress. This changes RRS 62.1(a).

10. HEARING REQUESTS

- 10.1. The protest time limit is 60 minutes after last boat has finished the race.
- 10.2. Hearing request forms are available on the Official Notice Board.
- 10.3. Notices will be posted no later 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the protest room, located at Pointe-Claire Yacht Club.
- 10.4. Notices of protests by the race committee or protest committee will be posted to inform boats under RRS 61.1 b)

COURSE #	FLAG DISPLAYED	COURSE
1	 Numeral pennant 1	Start at 32 – 34P – 44P – 33S – 43P – 31P – Finish at 32
2	 Numeral pennant 2	Start at 32 – 31S – 43S – 33P – 44S – 34S – Finish at 32

The letter P after the number of a mark signifies that the mark shall be left to port.

The letter S after the number of a mark signifies that the mark shall be left to starboard.
