Pointe-Claire Yacht Club, Pointe-Claire, Québec Organizing Authority: Pointe-Claire Yacht Club (PCYC)

1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing.
- 1.2. If there is a conflict between languages, French will take precedence.
- 1.3. Some RRS may be changed in the Sailing Instructions.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta event will initially be limited to the following classes of boats: **Optimists**, **Optimist** Green, ILCA 4 (Laser 4.7), ILCA 6 (Laser Radial), and Club 420. It is possible to accept other classes; a different scoring may be used.
- 2.2 Competitors in the ILCA classes may choose Radial or 4.7 rigs but must use the same rig for all the event.
- 2.3 A minimum of 5 registrations made at least 5 days before the event is required to constitute a class.
- 2.4 All competitors must sign the liability form. If the competitor is under 18 years of age, the form must be signed by the legal guardian. All competitors must provide proof of age.
- 2.5 Registration will be completed when all the necessary documents and full payment has been submitted. To be eligible for reduced prices fees must be received by the deadline.
- 2.6 All competitors must have been born in 2005 or after.

3. FEES

3.1 Fees for the regatta include Saturday dinner and all taxes.

- 3.2 Registration forms are available on the Pointe Claire Yacht Club website: www.pcyc.qc.ca. After July 4th, 12 PM. registration will be on-site between 3PM to 8PM July 4 and from 9AM and 10AM July 5th.
- 3.3 Through the PCYC webesite, payments will be done via credit card on payable forms. For registration on site, cheques should be made payable to Pointe Claire Yacht Club. Any athlete who has not paid before the regatta will be considered not registered for the regatta. For other forms of payment, contact the office.
- 3.4 There is no fee for a support boat with or without a coach, but support boats must be registered at the club office.

4.2. No warning signal will be given after 15h00 on the last day of the regatta.

5. SAILING INSTRUCTIONS

Sailing instructions will be available at the club's Official Notice Board on the veranda and on the PCYC website.

6. COMMUNICATION

- 6.1 Any additional communications will be displayed to the Official Notice Board on the veranda and to the PCYC website www.pcyc.qc.ca.
- 6.2 While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

7. COURSES

The courses to be sailed will be windward-leeward races.

8. SCORING

- 8.1. Seven races for each class are scheduled. .
- 8.2. One race is required to be completed to constitute a series.
- 8.3. When fewer than five races have been completed, a boat's series score will be the total of the race scores.
- 8.4. When five or more races have been completed, a boat's series score will be the total of the race scores excluding her worst score.
- 8.5. This regatta is considered a qualifying event and the scoring will be counted to determine overall results for the Circuit du Québec.

9. SUPPORT BOATS

- 9.1. Support boats shall keep 50 metres clear of the racing area during races, except for Green Fleet Coaches.
- 9.2. Support boats shall be identified with the boat's or coach's name.

10. BERTHING

- 10.1. Boats must be kept in their assigned areas in the boat park.
- 10.2. Trailers must be stored in the area assigned by the club.
- 10.3. Support boats must dock as directed by PCYC shore staff.

11. PRIZES

Prizes will be awarded to the top 3 finishers of each class except Opti-Green Fleet.

12. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Racing Rules of Sailing RRS 3, Decision to Race. The organizers and Pointe Claire Yacht Club will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

13. **MEDIA AND IMAGES**

By registering, each participant in this regatta gives authorization and cedes rights for the use and reproduction of pictures and videos, of themselves and of their boat during the sailing event, in the prospect of being published in any type of Web media, newspapers, or advertisement.

14. INSURANCE

Each participating boat shall be insured with valid third-part liability insurance with a minimum cover of \$500,000.00 or the equivalent, per incident. The organization accepts no responsibility for the verification of insurance.
