1 Environmental BEST PRACTICES SUPPORT

Prepare and communicate information for members and staff covering Initiatives already implemented, identifying the AWARENESS, SUPPORT and COMPLIANCE expected.

2 Maintain Environmental Initiatives

Ensure communication, monitoring and support efforts are undertaken by GREEN TEAM and STAFF to maintain Initiatives already implemented.

3 Create ANNUAL CALENDAR of Environment Committee TASKS. Prompt GREEN TEAM, MANAGER and EXECUTIVE Officers throughout the season, regarding their respective TASKS to ensure the ongoing continuity of our Environmental Best Practices.

4 Conduct REVIEW of HEATING / COOLING SYSTEMS to determine environmental and cost implications / feasability of conversion to electric.

5 Review and IMPROVE Environment component of Junior Sail Training Program.

6 Organize a couple of Environmental Presentation / Discussion evenings.

Examples:-- Ecology of Lac St. Louis, Organization Bleue speaker, City of Pointe-Claire speaker.

7 Source good-quality reusable WATER BOTTLES with Club logo for SALE to members.

8 Waste Management Practices for Boatyard and Work areas. To collaborate with the Manager and MAL– Buildings & Grounds improve Waste Management Practices related to activities by Staff, Boat Owners, Contractors.

9 Gray Water Disposal

Install OUTDOOR SINK and connected to sewer system. For use by members to wash dishes used in the BBQ area and on boats; and to dispose of wastewater and other liquids appropriate for the sewer system.

10 Update Harbour & Storage Regulations and CLUB Regulations. Collaborate with Harbour Master, MAL– Buildings & Grounds and EC to add / synchronize with, Environmental Best Practices as appropriate.

11 Sustainability considerations for Infrastructure Work with the Executive Officers and the Infrastructure Committee, in particular, to ensure Club projects are planned and implemented taking Environmental and Sustainability considerations into account.

12 Fuel-spill protocol

To collaborate with the Manager and Harbour Master to document a fuel-spill protocol to be followed in the event of a fuel incident in the harbour. The necessary materials have already been ordered and received.

13 City of Pointe-Claire Relationship

Continue to strengthen environmental relationship with City, and develop synergies for mutual GREEN Initiatives.
